Rental Terms and Conditions

- The normal rental period is for a maximum of **3 days**. Items are to be picked up **between 9a.m. and 6 p.m.** if rented between Tuesday-Saturday or if picking up on Sunday, 9-3pm the day before your event date. (Subject to holidays, special pick up and drop off time may be negotiated)
- Items must be returned **by 5:30pm** Tuesday-Saturday or if dropping off on Sunday, by 2 p.m. the day after your event.
- All items will be cleaned, packed, and ready for your pick up at your reserved time. All items must be returned in the same manner. Extended rentals are also available at an additional cost.

1. Customer shall use all property in a careful and proper manner, shall comply with all applicable laws and regulations, and shall return the property in the same condition and good repair as when received. Customer hereby assume all risk of loss and damage to the property from any cause whatsoever.

2. Responsibility of the rentals remains with the customer from the time of pickup/ delivery until the time of return. Customer agrees that all rentals are protected from weather (i.e. tarp, protective cover) at all times and secured when not in use.

3. A down payment of 50% of the total Rental Agreement is required to reserve your date and items selected. Please note: ALL DOWN PAYMENTS to reserve your items are NON REFUNDABLE. **The remaining 50% of the total rental agreement must be paid 10 days prior to event date. A credit card will be kept on file, at time of pick up, for any damages that are incurred** . If all items are returned safely without damage, your credit card copy will be shredded in your presence. Items on rental contract are final 10 days prior to rental date and cannot be changed.

4. All rental items must be returned to Plush Home and Fashion within the rental period specified on the contract for services. Customer will have extended rental charges of 150% of rental fee assessed for each 24 hour period it is late. If items are not returned within 4 days of the "Drop Off" information date listed in the contract for services, such failure shall constitute an unauthorized taking Event Inspirations may consider such items stolen and take all steps necessary to recover said items, including taking legal action, charging the customer at cost price thereof, and shall be due upon billing in addition to the rental charge.

Items may be rented for an extended period, beyond the 3 days, for an extra cost. The cost per extra day will be 25% of total rental quote.

Rental Requirements for Pick UP

Rentals must be picked up in a secure vehicle. Some larger items may require a truck. If you are renting large items, please bring tie downs to secure the items. Protective sheets or material must be used to properly transport items. Failure to follow these requirements may result in termination of rental.

All items may be disassembled by Event Inspirations for proper storage and transportation for a customer's event.

Delivery Fee AND/OR Pick Up Fee

We offer delivery and/or pickup service for the following fees and must be agreed upon in advance for scheduling. ***All items shall be placed back in their original packaging, organized, and ready to be picked up upon agreed time. If items are not ready or organized, 10% of the 25% damage deposit will be charged to the customer.***

\$100 per pickup/delivery within 50- mile radius.

Additional \$25 per pick up or delivery trip plus \$.50 per mile for destination over 50 miles.

Set Up and Design Services

We offer set up and design services for our rental items, as well as items not rented from Event Inspirations upon request.

\$75/hr for a minimum of 4 hours with 2 staff members

*2 hour set up and 2 hour take down=4 hour minimum

*** if additional staff is needed, the additional cost will be \$25/hr**

Refunds

There will be no refunds or credits issued for cancellations of event, inclement weather, or for any items that have been reserved but unused. Please review your items carefully on the Contract for Services. Once items are agreed upon, they cannot be cancelled.
